PARENTAL DISCLOSURE AND RESPONSIBILITY AGREEMENT

We (I) are(am) requesting that the Public Access Television Studio (PAT) of Calaveras County allow our(my) minor child, _____, to use the facilities of PAT. In this regard, we(I) make the following statements and promises:

1. We (I) are (am) the parent(s) or legal guardian(s) (circle one) of this minor child. (If only one parent signs this agreement, I state that I am the only parent or legal guardian (circle one) of the minor child). If two parents or guardians are responsible for our minor child, I have the authority to bind the other parent or guardian by my signature – otherwise both parents or guardians must sign this form.
2. We (I) understand that the use of PAT facilities includes reserving and using the Studio and edit suites, checking out portable equipment such as video cameras, microphones, and lights and use of other sophisticated and expensive electronic media equipment.
3. We (I) have read PAT's rules as well as all the user agreement forms for equipment and facilities that will be used. We (I) understand what responsibilities are required of people using PAT facilities and equipment and know that our(my) minor child understands these responsibilities and will comply with PAT rules. If not, we (I) agree to supervise our (my) minor child's use of PAT facilities and equipment to ensure that the responsibilities are met.
4. We (I) agree to assume full responsibility for our (my) minor child's use of PAT's facilities, and to assume responsibility for our(my) minor child's obligations as a user under PAT's operating rules, and under PAT's equipment check out agreement. We (I) agree to indemnify, defend and hold harmless Calaveras County, its Board of Supervisors, County Officers, County employees, the Management and its employees of PAT Studio from any and all claims, damage, and litigation arising out of our (my) minor child's actions or program material that our (my) minor child has produced.
5. We (I) are (am) asking PAT to allow our (my) minor child to reserve, check out and use PAT's facilities and equipment on an ongoing basis without further need to secure our(my) consent. We (I) ask and understand that this request and agreement will continue in effect and will apply to all subsequent use by our(my) minor child of PAT's facilities and equipment until we (I) notify PAT in writing to the contrary, or until our (my) minor child reaches eighteen (18) years of age, whichever occurs first.
6. We (I) have read, signed and agree to the "Application Form", "Statement of Responsibility and Compliance", "Responsibility for Borrowed Equipment", and "Standard Operating Rules".
